

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,  
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE  
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE THE  
5 SEGMENT OF TIMED NO PARKING ZONE ON IRVING STREET.

6 WHEREAS, the Public Works Department received a signed petition from one hundred  
7 percent (100%) of the three (3) residences located within the cul-de-sac on Irving Street north of  
8 Cherbourg Drive to remove the portion of the existing Timed No-Parking Zone on the west side  
9 of Irving Street from just south of the cul-de-sac bulb-out southerly to the south side of Cherbourg  
10 Drive; and

11 WHEREAS, additionally, seven (7) neighborhood residents located outside of the cul-de-  
12 sac, but within the immediate vicinity of the area of concern, signed the petition; and

13 WHEREAS, residents indicate that the restriction was implemented years ago to address  
14 overflow parking from nearby Arlington High School; and

15 WHEREAS, at that time, on-site parking availability was limited, and the surrounding  
16 neighborhood streets were utilized for overflow parking; and

17 WHEREAS, additionally, the school operated as an open campus which allowed students  
18 to leave the premises for lunch, which created high on-street parking turnover, however, the  
19 school has since changed to a closed campus; and

20 WHEREAS, the westerly school parking lot has been expanded and provides ample on-  
21 site parking for students, faculty, and visitors; and

22 WHEREAS, residents believe that these factors combined with the far northerly position  
23 of their properties on the street result in minimal overflow to Arlington High School parking on  
24 Irving Street north of Cherbourg Drive; and

25 WHEREAS, residents along this section of Irving Street have shared that they have not  
26 observed overflow school parking near their properties; and

27 WHEREAS, the removal of the proposed segment of Timed No-Parking Zone would  
28 increase on-street parking opportunities for residents and their guests to better meet their current  
parking needs; and

1           WHEREAS, the Timed No-Parking Zone would remain in effect on the westerly side of  
2 Irving Street from Lincoln Avenue to the south side of Cherbourg Drive and on the easterly side  
3 of the street from Lincoln Avenue to Cherbourg Drive; and

4           WHEREAS, on December 6, 2023, the Transportation Board unanimously approved  
5 staff's recommendation to remove the segment of existing "No-Parking between the hours of 8:00  
6 a.m. to 4:00 pm. Monday thru Friday, except holidays" zone on the west side of Irving Street  
7 from just south of the cul-de-sac bulb-out southerly to the south side of Cherbourg Drive as  
8 proposed.

9           NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
10 California, as follows:

11           Section 1: The recitals set forth above are incorporated herein by reference.

12           Section 2: That the Master Parking Schedule is hereby amended by removing the segment  
13 of existing "No-Parking between the hours of 8:00 a.m. to 4:00 p.m. Monday thru Friday, except  
14 holidays" zone on the west side of Irving Street from just south of the cul-de-sac bulb-out  
15 southerly to the south side of Cherbourg Drive.

16           Section 3: That the provisions of this resolution shall be operative only when signs are  
17 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
18 limitations or prohibitions herein established.

19           Section 4: The provisions of this amendment shall be operative as of the date of adoption  
20 of this resolution.
