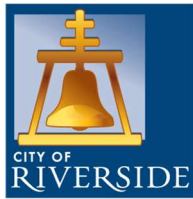

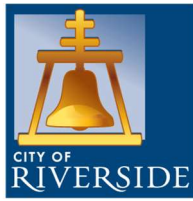

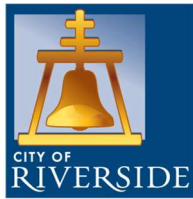
Following discussion, it was moved by Councilmember Hemenway and seconded by Councilmember Perry to (1) approve the First Amendment to Services Agreement with the Riverside-Corona Regional Conservation District in the additional amount of \$3,055,116.08 to increase the total contract amount to \$3,758,016.08 for Jurupa Avenue Extension Phase 2 from Rutland Avenue to Former Hole Lake Dam; (2) authorized the City Manager, or designee, to execute the First Amendment to the Services Agreement with the Riverside-Corona Regional Conservation District, including making minor and non-substantive changes, subject to the availability of budgeted funds; and (3) authorized the Public Works Department to prepare and submit a grant application to the California Natural Resources Agency under the Environmental Enhancement and Mitigation Program for an amount of up to \$750,000. The motion carried unanimously with Councilmember Cervantes absent.

The Mayor and City Council adjourned to Closed Session at 2:24 p.m. and returned to open session at 3:04 p.m. with all Councilmembers present except Councilmember Cervantes.

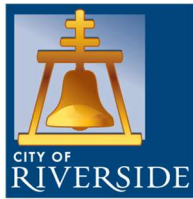
### PUBLIC HEARINGS/PLANNING REFERRALS AND APPEALS

#### WILLIAMSON ACT LAND CONSERVATION CONTRACT CANCELLATION - SINGLE-FAMILY RESIDENCE CONSTRUCTION - DIMINISHMENT OF PORTION OF AGRICULTURAL PRESERVE NO. 3 - LURIN/OBSIDIAN - RESOLUTION

Public Hearing was called to consider adopting a resolution approving the Tentative Cancellation of the Williamson Act Land Conservation Contract, Instrument No. 19065 (Assessor Parcel Number 266-090-021) and authorize the diminishment of the Woodcrest Agricultural Preserve No. 3 upon the execution and recording of the Certificate of Final Cancellation of Williamson Act Land, Conservation Contract, for an approximately 0.91-acre parcel, located on the north side of the Lurin Avenue and Obsidian Drive intersection. One person spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Mill and seconded by Councilmember Conder to approve the Land Use Committee recommendation to (1) adopt a Resolution based on the findings set forth in the staff report, approving the Tentative Cancellation of Williamson Act Land Conservation, Instrument No. 19065 (Assessor Parcel Number 266-090-021); (2) authorize the City Manager, or his designee, to execute and record the Certificate of Tentative Cancellation of Williamson Act Land Conservation Contract; (3) authorize the City Manager, or his designee, to execute and record the Certificate of Final Cancellation of Williamson Act Land Conservation Contract upon notice of satisfaction of all conditions and contingencies required in the Certificate of Tentative Cancellation, and to execute any and all documents necessary to effectuate the cancellation of the Williamson Act Conservation Contract; and (4) record the Certificate of Final Cancellation of the Williamson Act Land Conservation Contract and adopt a Resolution authorizing the diminishment of the Woodcrest Agricultural Preserve No. 3. The motion carried unanimously with Councilmember Cervantes absent.

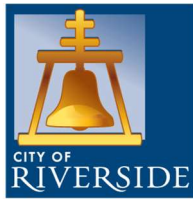
### CITY SPIRIT AWARD NOMINATION PROCESS AND CRITERIA
