## **RESOLUTION NO.**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, CONFIRMING THE DIAGRAM AND ASSESSMENT FOR STREET LIGHTING DISTRICT NO. 1, AND LEVYING ASSESSMENTS ON ALL ASSESSABLE LOTS AND PARCELS OF LAND THEREIN FOR THE FISCAL YEAR 2015-2016.

6 WHEREAS, on June 16, 2015, the City Council (the "City Council") of the City of 7 Riverside, California (the "City"), adopted Resolution No. 22857, a resolution of intention 8 pursuant to section 22624 of the Streets and Highways Code of the State of California which, 9 among other things, scheduled a hearing on the proposed levy and collection of assessments on 10 all lots and parcels of assessable land in Street Lighting District No. 1 for the fiscal year 2015-11 2016 for the installation or construction of public lighting facilities, the installation or 12 construction of any facilities which are appurtenant to such public lighting facilities or which are 13 necessary or convenient for the maintenance or servicing thereof, including grading, clearing, 14 removal of debris, and the installation or construction of curbs, gutters, walls, sidewalks or 15 paving, or electrical facilities, and the maintenance and servicing of such public lighting 16 facilities. The hearing was scheduled for July 14, 2015, at 3:00 p.m., in the City Council 17 Chambers, 3900 Main Street, Riverside, California; and

WHEREAS, notice of said hearing was duly published as required by said resolution and
section 22626 of the Streets and Highways Code; and

WHEREAS, at the time and place of said hearing, as set forth in said resolution, the City Council held the hearing and afforded all interested persons an opportunity to hear and be heard, and considered all oral statements and all written protests or communications made or filed by any interested persons; and

WHEREAS, pursuant to section 22630 of the Streets and Highways Code, the City Council may order changes in any of the matters provided for in the report of Albert A. Webb Associates, including changes in the proposed assessments, and the City Council has determined that it is necessary and desirable that the proposed assessments on all lots and parcels of

assessable land in all assessment zones of Street Lighting District No. 1 for the 2015-2016 fiscal 1 2 year shall be at the level as listed in Section 3 below; and

WHEREAS, the City Council may proceed, pursuant to section 22631 of the Streets and Highways Code, to adopt a resolution confirming the diagram and assessment, either as 4 5 originally proposed, or as changed by it, and the adoption of such a resolution shall constitute the levy of an assessment on all assessable lots and parcels of land within Street Lighting District 6 7 No. 1 for the fiscal year 2015-2016.

8 NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the 9 City Council of the City of Riverside, as follows:

Section 1. Findings. The City Council finds:

(a) The preceding recitals are correct;

12 (b) Compliance has been had with all of the requirements of the Landscaping and Lighting Act of 1972, Part 2 (commencing with Section 22500 of Division 15 of the Streets and 13 14 Highways Code);

15 (c) The City Council may proceed to adopt a resolution confirming the diagram and 16 assessment either as originally proposed or as changed by it;

17 (d) The assessments proposed to be levied on the assessable lots and parcels of land in all assessment zones of Street Lighting District No. 1 for the maintenance and servicing of public 18 19 lighting facilities in the City during the fiscal year 2015-2016 contained in the report of Albert A. Webb Associates, on file with the City Clerk (the "Report") are listed below in Section 3; 20

21 (e) The assessments proposed to be levied on the assessable lots and parcels of land in 22 Street Lighting District No. 1 for the maintenance and servicing of public lighting facilities in the 23 City during the fiscal year 2015-2016 contained in the Report and in Section 3 hereof are based 24 on the benefit derived by such lots and parcels from the availability of such public lighting 25 facilities, and are not based upon the ownership or value of such lots and parcels.
