Dear Council Members:

In preparation for the review by the City Council Governmental Affairs Committee, the Board of the Riverside Public Utilities (RPU) discussed the Code of Ethics and Conduct at its August 7, 2015 meeting. The RPU Board recognizes that Resolution No. 22461 is currently under review by a special committee. That being the case, the RPU Board has chosen to submit the same suggested modifications it provided to the City Council at the last review, as they are still relevant.

- 1. The chairs of boards and commissions should not be used as members of hearing panels.
- 2. There needs to be adequate grievance processes for city employees, other than their utilization of the Code of Ethics procedures.

The RPU Board has chosen to also submit an additional recommendation:

3. The responsibility for civility in public meetings should also include the public as well as elected and appointed officials.

## Rationale:

The current resolution encourages both elected and appointed officials to practice civility and decorum during public meetings. The resolution should also include that civility by the public is also important in achieving open, transparent, and effective government.

During the past year RPU Board members and staff have been personally insulted, demeaned, bullied, and slandered by members of the public during public meetings. Further, two members of the public even went to a RPU board member's place of employment in what might be interpreted as an act of intimidation. These actions have a chilling effect on the open exchange of ideas, deliberations, and discussions in the decision-making process. The incivility of some members of the public, aimed at personal destruction, needs to be addressed as it detracts from the free exchange of ideas and the democratic process.
