

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE THE
5 EXISTING NO PARKING AT ALL TIMES ZONE ON WESTERLY SIDE OF
6 HARDING STREET SOUTH OF ARLINGTON AVENUE.

7 WHEREAS, the Public Works Department received a request from Harding Street
8 residents to review on-street parking in their residential neighborhood due to overflow parking
9 from neighboring Arlington Avenue businesses; and

10 WHEREAS, review of the site found a small existing no parking zone in place on the west
11 side of the street adjacent to 3772 Arlington Avenue with one restriction sign located within an
12 existing segment of red curb; and

13 WHEREAS, the Public Works Department proposed the removal of the existing No
14 Parking At All Times Zone to provide additional on-street parking for business patrons and
15 reduce overflow parking into the residential area; and

16 WHEREAS, the removal of the zone will provide approximately three additional on-street
17 parking spaces in close proximity to the Arlington Avenue businesses and reduce overflow
18 parking into the residential portion of the neighborhood; and

19 WHEREAS, on August 5, 2015, the Transportation Board approved staff's
20 recommendation to a) remove the existing "No Parking Any Time" Zone on the westerly side of
21 Harding Street from Arlington Avenue to 150 feet southerly thereof.

22 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
23 California, as follows:

24 Section 1: The recitals set forth above are incorporated herein by reference.

25 Section 2: That the Master Parking Schedule is hereby amended by a) removing the
26 existing "No Parking At All Times" Zone on the westerly side of Harding Street from Arlington
27 Avenue to 150 feet southerly thereof.

Section 3: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
