Permit Tracking Software

- July 2013, Request for Information (RFI) issued to evaluate permit tracking replacement software options.
- August 2014, Request for Proposals (RFP) 1470 issued to companies from the RFI

- Top 3 provided a live demonstration to a multi-departmental user committee

POSSE by Computronix

POSSE LMS from Computronix is:

- a Land Management System
- a web-based application designed to provide internal and external users real time status and information

POSSE LMS from Computronix is:

- integrated with contractor licensing and management
- an online application, submission and payment system
- accessible from any web accessible device (smart phone, tablet, PC, etc.)

Technology Funding

On September 8, 2015, the City Council approved an update to the City's User Fees & Charges Study that included a 4% technology cost recovery component that:

- is integrated with fees related to development activity.
- will fund the cost of the General Fund portion of the costs
- was calculated based on a 6 year cost
 recovery of project cost

RECOMMENDATION

- 1. Receive an update on the Business Ready Riverside Strategy, Business Ready Riverside 2.0 Strategy and Red Carpet Riverside;
- 2. Authorize a supplemental appropriations related to permit software replacement:

\$1,805,817 for the General Fund share;

\$332,757 for the Electric Fund share (Fund 510);

\$135,915 for the Water Fund share (Fund 520);



RECOMMENDATION Cont.

- 3. Adopt the Reimbursement Resolution
- 4. Authorize an increase in estimated revenue of \$1,805,817 for the future capital lease;
- 5. Approve an Annual Product Support Agreement for POSSE Clients, POSSE One-Time Perpetual Software License Agreement, and Professional Services Agreement with Computronix (U.S.A), Inc., for \$1,307,870
- 6. Authorize the City Manager or his designee to execute the documents necessary to complete the transaction.
