AND JESSIE C. SHAW HOUSE. 5 The City Council of the City of Riverside, California, does ordain as follows: 6 Section 1: Pursuant to Chapter 19.090 of the Riverside Municipal Code, the Zoning Map of 7 the City of Riverside is amended by applying the Cultural Resource Overlay Zone ("CR") Zone to 8 City Landmark No. 129, the James E. and Jessie C. Shaw House, located at 8410 Cleveland Avenue 9 as described and depicted in Exhibit "A", attached hereto and incorporated herein by reference, 10 subject to all of the conditions, restrictions and covenants imposed under Planning Case Number 11 P15-0555 which conditions, restrictions and covenants are incorporated herein by reference. 12 Section 2: The City Council has reviewed the matter and, based upon the facts and 13 information contained in the staff reports, administrative record, and written and oral testimony, 14 hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 16 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment. 17 Section 3: The City Clerk shall certify to the adoption of this ordinance and cause 18 publication once in a newspaper of general circulation in accordance with Section 414 of the Charter 19 of the City of Riverside.
