

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REVISE THE
5 BOUNDARIES OF THE EXISTING 20-MINUTE PARKING ZONE ON THE
6 SOUTH SIDE OF NINTH STREET EAST OF MAIN STREET.

7 WHEREAS, the Public Works Department is installing on-street disabled/ADA parking
8 stalls within existing diagonal parking stalls in the core Downtown Area; and

9 WHEREAS, a van accessible disabled/ADA parking stall is scheduled to be installed on
10 the south side of Ninth Street east of Main Street which would impact two (2) 20-Minute Parking
11 spaces to install a disabled/ADA parking stall and aisle; the two easterly 20-Minute Parking stalls
12 will remain in place; and

13 WHEREAS, a revision of the zone boundaries is necessary to accurately reflect the
14 remaining 20-Minute Parking Zone in the Master Parking Schedule; and

15 WHEREAS, on October 7, 2015, the Transportation Board approved staff's
16 recommendation to revise the boundaries of the existing 20-Minute Parking Zone on the south
17 side of Ninth Street east of Main Street.

18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
19 California, as follows:

20 Section 1: The recitals set forth above are incorporated herein by reference.

21 Section 2: That the Master Parking Schedule is hereby amended by revising the
22 boundaries of the existing "20-Minute Parking between the hours of 9:00 a.m. to 5:00 p.m.
23 Monday thru Friday, except holidays" Zone on Ninth Street from "south side from Main Street
24 encompassing the first four parking stalls easterly thereof" to "south side from Main Street
25 encompassing the second and third parking stalls easterly thereof.

26 Section 3: That the provisions of this resolution shall be operative only when signs are
27 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
28 limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
