

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING THE LAND USE AND URBAN DESIGN ELEMENT OF THE GENERAL PLAN 2025 AS TO APPROXIMATELY 7.7 ACRES OF LAND LOCATED AT 18171 VAN BUREN BOULEVARD, SITUATED AT THE SOUTHWESTERLY CORNER OF VAN BUREN BOULEVARD AND LITTLE COURT.

WHEREAS, an application was submitted to the City of Riverside designated as Planning Case P13-0247, to amend the Land Use and Urban Design Element of the General Plan 2025 as to approximately 7.7 acres of land located at 18171 Van Buren Boulevard, situated at the southwesterly corner of Van Buren Boulevard and Little Court ("Property") from the Very Low Density Residential ("VLDR") land use designation to the Commercial ("C") land use designation; and

WHEREAS, on September 3, 2015, the Planning Commission of the City of Riverside held a public hearing to consider the proposed amendment to the Land Use and Urban Design Element of the General Plan 2025 and recommended to the City Council that the amendment be approved to change the land use designation of the Property from the Very Low Density Residential ("VLDR") land use designation to the Commercial ("C"), land use designation;

WHEREAS, the City Council of the City of Riverside advertised for and held a public hearing on December 1, 2015, to consider Planning Case No. P13-0263; and

WHEREAS, the City Council received and considered the reports and recommendation from the Planning Commission and all other testimony, whether written or oral, presented at the public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: It is in the public interest to amend the Land Use and Urban Design Element of the General Plan 2025 as more particularly described below.

<u>Section 2</u>: The amendment will not have a significant effect on the environment and a mitigated negative declaration is hereby adopted.
