The annual report of the Riverside Downtown Partnership, acting in its capacity as the 14 advisory board to the Downtown Parking and Business Improvement Area, is hereby 15 confirmed. 16 2. The levy of assessments for the Downtown Parking and Business Improvement Area is 17 hereby imposed for calendar year 2016 on each business entity within the Area at the rate 18 of 100% of the business tax charge paid by that entity, as set forth in Riverside Municipal 19 Code 3.46.060, and which shall provide specific services and benefits directly to each 20 business entity within the Area subject to the assessment at a cost which does not exceed 21 the reasonable cost in providing the services and benefits. 22 ADOPTED by the City Council this _____ day of ______, 2015. 23 24 WILLIAM R.
