A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A PREFERENTIAL PARKING ZONE ON OSBURN PLACE.

WHEREAS, the Public Works Department received a petition from 89% of residents on Osburn Place from Bandini Avenue to Linwood Place requesting establishment of a Preferential Parking Zone ("PPZ"). The residents indicate that overflow parking from nearby apartment complexes is limiting on-street parking opportunities for residents and their guests; and

WHEREAS, the establishment of the PPZ would restrict outside parking sources and provide residents and their guests with reasonable access to on-street parking; and

WHEREAS, on December 2, 2015, the Transportation Board ("Board") unanimously denied the proposal to establish the proposed "No Parking Any Time, with Preferential Permit Parking for residents" Zone on both sides of Osburn Place from Bandini Avenue to Linwood Place. Though the Board did not recommend establishment of the proposed PPZ on Osburn Place, minimum petition criteria for establishment of the zone was exceeded showing strong neighborhood support for creation of the zone.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

<u>Section 2</u>: That the Master Parking Schedule is hereby amended by establishing a "No Parking Any Time, with Preferential Permit Parking for residents" Zone on both sides of Osburn Place from Bandini Avenue to Linwood Place.

<u>Section 3</u>: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
