## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A PREFERENTIAL PARKING ZONE ON ELMWOOD COURT.

WHEREAS, the Public Works Department received a petition from 90% of residents on Elmwood Court requesting establishment of a Preferential Parking Zone ("PPZ") due to the overflow student parking from nearby Riverside City College, which is impacting on-street parking opportunities for residents and their guests; and

WHEREAS, the establishment of the PPZ would restrict outside parking sources during peak school days and times and provide residents and their guests with reasonable access to onstreet parking; and

WHEREAS, on December 2, 2015, the Transportation Board approved staff's recommendation on the establishment of the proposed "No Parking between the Hours of 6:00 a.m. to 8:30 p.m. Monday through Friday except holidays with Preferential Permit Parking for residents" Zone on both sides of Elmwood Court from Magnolia Avenue to Elmwood Drive.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by establishing a "No Parking between the Hours of 6:00 a.m. to 8:30 p.m. Monday through Friday except holidays with Preferential Permit Parking for residents" Zone on both sides of Elmwood Court from Magnolia Avenue to Elmwood Drive.

<u>Section 3</u>: That the provisions of this resolution shall be operative only when signs are erected on that portion of the street set forth in Section 2 above, giving notice of the parking limitations or prohibitions herein established.

<u>Section 4</u>: The provisions of this amendment shall be operative as of the date of adoption of this resolution.
