

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, APPROVING THE DESIGNATION OF THE
4 CITY MANAGER OR APPOINTED DESIGNEE, TO EXECUTE
5 DOCUMENTS FOR THE CALIFORNIA OFFICE OF EMERGENCY
6 SERVICES ("CAL OES") SPECIAL TRANSPORTATION CAPITAL
7 PROGRAM

8 WHEREAS, the Legislature and Governor of the State of California have provided funds for
9 the program shown above; and

10 WHEREAS, after City Council approval on February 2, 2016, the Parks, Recreation and
11 Community Services Department shall submit a Grant Application to the California Office of
12 Emergency Services ("Cal OES") in the amount of \$48,452 to install additional lighting and cameras
13 within and near the Special Transportation parking lot, CNG Vehicle Maintenance Facility and
14 Operations Facility, and to purchase emergency response and security equipment; and

15 WHEREAS, procedures established by Cal OES require a resolution appointing an
16 authorized agent to execute any actions necessary for the Grant Application; and

17 WHEREAS, the City of Riverside desires to complete the necessary documents for award of
18 the Grant.

19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
20 California, as follows:

21 Section 1: Appoints the City Manager, or his appointed designee, as agent to execute for
22 and on behalf of the City of Riverside, a public entity, established under the laws of the State of
23 California, any actions necessary for the purpose of obtaining financial assistance provided by Cal
24 OES.
