## ORDINANCE NO.

AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING SECTION 2.04.010 OF THE RIVERSIDE MUNICIPAL CODE RELATING TO THE TIME FOR HOLDING OF REGULAR MEETINGS OF THE CITY COUNCIL TO CHANGE THE FREQUENCY AND TIME OF SUCH MEETINGS.

The City Council of the City of Riverside does ordain as follows:

Section 1: Section 2.04.010 of the Riverside Municipal Code is hereby amended to read as follows:

2.04.010 TIME OF REGULAR MEETINGS. Except for the months of July and, August, and September, the regular meetings of the Mayor and City Council shall be held on the first, second, third and fourth Tuesdays of each month at the approximate hour of 2:00 p.m. During the months of July and, August and September, the regular meetings shall be held on the second and fourth Tuesdays of said months at the approximate hour of 2:00 p.m., and said Mayor and City Council shall not have regular meetings on the first and third Tuesdays of said months. No meeting shall be held if the meeting date follows a City holiday on the immediately preceding Monday.

Section 2: The City Council has reviewed the matter and, based upon the facts and information contained in the staff reports, administrative record, and written and oral testimony, hereby finds that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3) and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, in that it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment.

Section 3: The City Clerk shall certify to the adoption of this ordinance and cause publication once in a newspaper of general circulation in accordance with Section 414 of the Charter of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its adoption.
