RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO REMOVE THE EXISTING 2-HOUR AND 20-MINUTE PARKING ZONES ON DESIGNATED PORTIONS OF FIFTH STREET AND ORANGE STREET AND FROM THE MASTER PARKING SCHEDULE.

WHEREAS, the Encore High School for the Arts expanded its operations to include a new campus at the property located at 3640 Orange Street. The school has requested that the Public Works Department remove the existing Timed Parking Zones on the Fifth Street and Orange Street side for their new location to allow for the creation of student passenger loading and unloading zones during peak school drop-off and pick-up times; and

WHEREAS, due to the change in occupants at this property, Timed Parking Zones are no longer needed; and

WHEREAS, the removal of the Timed Parking Zones would provide an area for designated student loading and unloading immediately adjacent to the new Encore High School campus to facilitate the efficiency of student drop-off and pick-up as well as update the Master Parking Schedule; and

WHEREAS, on October 7, 2015, the Transportation Board approved staff's recommendation to remove the existing 2-Hour and 20-Minute Parking Zones on designated portions of Fifth Street and Orange Street and from the Master Parking Schedule; and

WHEREAS, on December 10, 2015, the Transportation Committee approved staff's recommendation to remove the existing 2-Hour and 20-Minute Parking Zones on designated segments of Fifth Street and Orange Street and from the Master Parking Schedule and specified that the passenger loading zone established for Encore High School be in effect during school hours only to allow for unrestricted parking outside of school hours to provide additional on-street parking opportunities in the busy Downtown area.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

1           Section 1: The recitals set forth above are incorporated herein by reference.

2           Section 2: That the Master Parking Schedule is hereby amended by a) removing the  
3 existing “2-Hour Parking between the hours of 9:00 a.m. to 6:00 p.m. of any day except Sunday  
4 and holidays” Zone on both sides of Fifth Street from Orange Street to Lemon Street from the  
5 Master Parking Schedule; b) removing the existing “20-Minute Parking between the hours of 8:00  
6 a.m. to 5:00 p.m. except Saturday, Sunday and holidays” Zone on the east side of Orange Street  
7 from Fifth Street to 143 feet northerly thereof; and c) removing the existing “2-Hour Parking  
8 between the hours of 9:00 a.m. to 6:00 p.m. of any day except Sunday and holidays” Zone on the  
9 east side of Orange Street from 143 feet north of Fifth Street to Third Street.

10           Section 3: That the provisions of this resolution shall be operative only when signs are  
11 erected on that portion of the street set forth in Section 2 above, giving notice of the parking  
12 limitations or prohibitions herein established.

13           Section 4: The provisions of this amendment shall be operative as of the date of adoption  
14 of this resolution.
