7	WHEDEAS the City has contracted with the Diverside Unified School District		
	WHEREAS, the City has contracted with the Riverside Unified School District

10	Department ("PRCSD") through the Summer Lunch Program; and		
11	WHEREAS, the Summer Lunch Program has been funded by grants from the California		
12	Department of Education and PRCSD is submitting a new application for a grant to cover the		
13	2016 Summer Lunch Program; and		
14	WHEREAS, ten park sites have qualified under Federal Guidelines for the Summer		
15	Lunch Program; and		
16	WHEREAS, the City and RUSD have a positive working relationship and have strived to		
17	maintain open communication and improve the Summer Lunch Program each year; and		
18	WHEREAS, in 2015, the Summer Lunch Program boasted excellent tasting meals,		
19	service, and a high number of participants and revenue to cover food labor costs for the program;		
20	and		
21	WHEREAS, the PRCSD would not be able to provide funding for the Summer Lunch		
22	Program without the grant from the California Department of Education; and		
23	WHEREAS, the Federal Guidelines for the Summer Lunch Program allow participating		
24	agencies to contract with a local school district for the preparation of meals without going		
25	through the competitive bidding process; and		
26	WHEREAS, given the past working relationship with RUSD and the past success of the		
27	Summer Lunch Program, staff believes that continuing to contract with RUSD is in the City's		
28	best interest because the price and quality of meals and service provided by RUSD are

2 WHEREAS, the City's Purchasing Services Manager, based upon the foregoing, has 3 determined that it is in the best interest of the City to waive the competitive bidding requirements 4 of Purchasing Resolution No. 22576, under Section 201(i), and to contract with RUSD to 5 provide lunches for the 2016 Summer Food Program in an amount not to exceed Two Hundred Twenty Thousand Eight Hundred Seventy Five Dollars (\$220,875.00). 6

7 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 8 California, as follows:

9 Section 1: On the basis of the foregoing recitals and the staff report accompanying this 10 Resolution, the competitive procurement requirements of Resolution No. 22576 are hereby 11 waived for the purposes of contracting with the RUSD to provide lunches for the 2016 Summer Food Program in an amount not to exceed Two Hundred Twenty Thousand Eight Hundred 12 13 Seventy Five Dollars (\$220,875.00).

14 Section 2: The Purchasing Services Manager is authorized to issue a purchase order in 15 an amount not to exceed Two Hundred Twenty Thousand Eight Hundred Seventy Five Dollars 16 (\$220,875.00) for this procurement.
