PLANNING CASES P15-0826 and P15-0827 - Conditional Use Permit, and Variance - 8223 California Avenue

Proposal by Sunnshine Schupp of Spectrum Services, on behalf of Verizon Wireless, to consider a Conditional Use Permit and Variance to permit a 55-foot high wireless telecommunications facility, camouflaged as a broadleaf tree that is higher than permitted by Code, on 4.79 acres developed with First Free Methodist Church of Riverside. Brian Norton, Senior Planner, presented the staff report. Sunnshine Schupp, Spectrum Services, stated they were in agreement with staff's recommendations. There were no comments from the audience. Following discussion the Planning Commission recommended that the City Council: 1) Determine that the proposed project will not have a significant effect on the environment based on the findings set forth in the case record and recommend City Council adoption of a Negative Declaration; and; 2) Approve Planning Cases P15-0826 and P15-0827 based on the findings outlined in the staff report and subject to the recommended conditions.
