SUBJECT: AWARD BID NO. 7382 FOR REMOVAL AND REPLACEMENT OF RESILIENT PLAYGROUND SURFACING AT VARIOUS CITY PARKS TO ROBERTSON INDUSTRIES INC., TEMPE, ARIZONA – AWARD CONTRACT FOR \$265,402

ISSUE:

Consideration to award bid no. 7382 and approve construction contract for removal and replacement of resilient playground surfacing at various City parks.

RECOMMENDATIONS:

That the City Council:

1. Award Bid No. 7382 Removal and Replacement of Resilient Playground Surfacing at Various City Parks (Table 1) to Robertson Industries, Inc., of Tempe, Arizona, in the amount of \$265,402; and
2. Authorize the City Manager, or designee, to execute a construction contract for Bid No. 7382.

BACKGROUND:

In order to continue providing safe play areas, the worn resilient playground surfacing at Don Derr Park, Sycamore Highlands Park, two Riverwalk Parks, and the Nati Fuentes Centro de Niños Childcare Facility at Bordwell Park are in need of replacement. The work at the Golden/Schuyler Riverwalk Pocket Park includes removal of the existing surfacing which is a combination of rubberized surfacing and wood chip surfacing with the replacement of poured-in-place rubber surfacing over the entire play area. The following Table includes the bid item, location and bid amount.

On March 14, 2016, the Purchasing Division posted bid documents on the City's website, and received two responsive and one non-responsive bids on April 21, 2016. The lowest bidder is Robertson Industries, Inc., of Tempe, Arizona. The Purchasing Services Manager's Bid Award Recommendation Report indicates the bid meets the criteria to be considered responsive and responsible. The State Contractor's Licensing Board records indicate this bidder's license is current, active, and in good standing.

The Purchasing Services Manager concurs with the bid award recommendation.
