Following discussion the Planning Commission recommended that the City Council: 1) Determine that Planning Cases P15-0983 and P15-0984 is exempt from California Environmental Quality Act (CEQA) review pursuant to Section 15303 (New Construction or Conversion of Small Structures) and Section 15332 (In-Fill Development Projects); and 2) Approve Planning Cases P15-0983 and P15-0984 based on the findings outlined in the staff report and subject to the recommended conditions.
