2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, IN SUPPORT OF THE CALIFORNIA PARK & RECREATION
4 SOCIETY “PARKS MAKE LIFE BETTER!®” CAMPAIGN.

5 WHEREAS, Parks and Recreation makes lives and communities better now and in the future;
6 and

7 WHEREAS, it is established through statewide public opinion research that 98% of
8 California households visit a local park at least once a year; two in three households visit a park once
9 a month; 50% of households participate in an organized recreation program; and most park use is
10 with family and friends; and

11 WHEREAS, residents value recreation as it provides positive alternatives for children and
12 youth to reduce crime and mischief especially during non-school hours, it promotes the arts, it
13 increases social connections, aids in therapy, and promotes lifelong learning; and

14 WHEREAS, parks provide access to the serenity and the inspiration of nature and outdoor
15 space as well as preserve and protect the historic, natural and cultural resources in our community;
16 and

17 WHEREAS, the residents of the City of Riverside, including children, youth, families, adults,
18 seniors, businesses, community organizations, and visitors benefit from the wide range of parks,
19 trails, open space, sports fields, tennis courts, facilities and programs provided by the Parks
20 Recreation and Community Services Department of the City of Riverside; and

21 WHEREAS, July is celebrated across the nation as Parks and Recreation Month.

22 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
23 California, as follows:

24 Section 1: The City of Riverside hereby joins with the California Park & Recreation Society
25 in promoting the “Parks Make Life Better!®” campaign, and declares July 2016 as “Parks Make Life
26 Better!® Month”, and in so doing, urges all its citizens to use and enjoy its parks, trails, open space,
27 facilities, and recreation opportunities.
