SUBJECT: AWARD BID NO. 7401 TO MYTHICS, INC. FOR THE PURCHASE OF ORACLE REAL APPLICATION CLUSTERS PROCESSOR PERPETUAL LICENSES IN THE AMOUNT OF \$83,661.51

ISSUE:

The issue for City Council consideration is to award Bid No. 7401 to Mythics, Inc. of Virginia Beach, Virginia (VA) for the purchase of Oracle real application clusters processor perpetual licenses in the amount of \$83,661.51.

RECOMMENDATION:

That the City Council award Bid No. 7401 to Mythics, Inc. of Virginia Beach, VA for the purchase of Oracle real application clusters processor perpetual licenses in the amount of \$83,661.51.

BACKGROUND:

The City of Riverside has used the Oracle database product in many of the City's data systems for at least 15 years. Systems using Oracle include CADME, Customer Relations Management (CRM), Customer Information System (CIS), Fleet M5 and others. Oracle is a very powerful tool and though there are other database systems available, any migration from Oracle would be a large-scale effort involving significant costs and implementation duration. The City's new Computronix permitting system and Oracle Virtual Machine (VM) system both require the purchase of Oracle licensing.

As a key implementation of its Business Ready Riverside Strategy, the City Council approved the replacement of the City's permitting system with a product from Computronix on October 6, 2015. This project will impact 120 users across seven city departments and impact integrations with most other core enterprise systems. The permitting system replacement requires new Oracle database software licenses. The City Council approved the budget appropriation for these licenses in conjunction with approval for of the Computronix system.

On April 29, 2016, the City issued Bid No. 7401 soliciting bids for the purchase of Oracle real application clusters processor perpetual licenses. The Bid closed on May 17, 2016 with three responses. Mythics, Inc. submitted the lowest qualified bid.

The City's Purchasing Manager concurs with the recommendation in this report.

FISCAL IMPACT:

The total cost for the licenses is \$83,661.51. Sufficient funding is available in Account No. 9892100885-46230500 (Permit Software – Computronix Computer System Upgrades) for the Computronix permitting system (\$78,054.63) and in Account No. 2410000-425700 (Innovation and Technology Operations Division Software Purchase/Licensing) for the Oracle VM licenses (\$5,606.88).
