AN ORDINANCE OF THE CITY OF RIVERSIDE, CALIFORNIA, LEVYING SPECIAL TAXES TO BE COLLECTED DURING FISCAL YEAR 2016-2017 FOR THE PAYMENT OF THE PRINCIPAL OF AND INTEREST ON AND ADMINISTRATIVE EXPENSES WITH RESPECT TO THE BONDS OF COMMUNITY FACILITIES DISTRICT NO. 2014-2 (THE HIGHLANDS) OF THE CITY OF RIVERSIDE, CALIFORNIA, AND DECLARING THIS ORDINANCE TO BE EFFECTIVE UPON ADOPTION.

The City Council of the City of Riverside does ordain as follows:

7 Section 1: Findings. It is necessary that the City Council of the City of Riverside levy 8 special taxes pursuant to sections 53340 and 53358 of the Government Code on parcels of 9 taxable real property within Community Facilities District No. 2014-2 (The Highlands) of the 10 City of Riverside (the "District") for the payment of the principal of and interest on the bonds of 11 the District, and for the payment of administrative expenses incurred in connection with the levy 12 and collection of said special taxes and the payment of such principal and interest.

Section 2: Levy of Special Taxes. Special taxes shall be and are hereby levied for the 14 fiscal year 2016-2017 on all parcels of real property within the District which are subject to 15 taxation, which are identified in Exhibit "A" attached hereto, and in the amount set forth for each 16 such parcel in said Exhibit "A." Pursuant to said Sections 53340 and 53358, such special taxes 17 for Fund 68-2743 shall be collected in the same manner as ordinary ad valorem property taxes 18 are collected and shall be subject to the same penalties and the same procedure, sale, and lien 19 priority in case of delinquency as is provided for ad valorem taxes.

20 Section 3: Transmittal to County. The City Clerk shall upon adoption of this ordinance 21 cause a copy to be transmitted to the County Auditor of the County of Riverside together with a 22 request that the special taxes as levied hereby be collected on the tax bills for the parcels 23 identified in Exhibit "A" hereto, along with the ordinary ad valorem property taxes to be levied 24 on and collected from the owners of said parcels.

25 Section 4: Publication and Effective Date. The City Clerk shall certify to the adoption of 26 this ordinance and cause publication once in a newspaper of general circulation in accordance 27 with Section 414 of the Charter of the City of Riverside. This is an ordinance fixing the rate of
