**RECITALS**

WHEREAS, on August 7, 2015, City and Consultant entered into that certain Professional Consultant Services Agreement for Examination and Performance Audit ("Agreement"); and

WHEREAS, City and Consultant have amended the Agreement two times, to add additional services to the scope of services and to extend the term to August 1, 2016.

WHEREAS, Consultant has requested additional time to complete the services under the Agreement; and

WHEREAS, City is in agreement with this request, and City and Consultant desire to extend the term of the Agreement by two months, to October 1, 2016, with no increase in compensation.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

1. Section 2 of the Agreement, entitled "Term," is hereby amended by extending the term to October 1, 2016.

2. All terms and conditions of the Agreement not inconsistent with this Third Amendment shall remain in full force and effect, and are incorporated herein by this reference as if set forth in full.
