

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE THE
5 EXISTING NO PARKING AT ALL TIMES ZONES ON DESIGNATED
6 SEGMENTS OF JASMINE STREET AND TO ESTABLISH TIMED PARKING
7 ZONES ON JASMINE STREET.

8 WHEREAS, the Public Works Department received a request from the Toro Company
9 and other area businesses to remove the existing No Parking Zones on Jasmine Street north of
10 Columbus Avenue to provide additional on-street parking for business patrons and employees;
11 and

12 WHEREAS, due to a change in business parking needs, removing the No Parking
13 restrictions would better meet current demands for on-street parking; and

14 WHEREAS, the removal of the No Parking Zones would provide the additional on-street
15 parking area businesses need to continue to grow and thrive; and

16 WHEREAS, on April 6, 2016, an additional constituent request was made directly to the
17 Transportation Board proposing the restriction of overnight parking within the same segments of
18 Jasmine Street between the hours of 6:00 p.m. to 6:00 a.m. to prohibit parking after typical
19 business hours. The newly proposed parking restrictions were requested to address security
20 concerns from area businesses in this commercial area stemming from late evening and overnight
21 parking. The Transportation Board reviewed each proposal and recommended approval of both
22 the original proposal to remove the existing No Parking Zones on designated portions of Jasmine
23 Street and the subsequent proposal received at the public meeting to establish Timed Parking
24 Zones within the same street segments.

25 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
26 California, as follows:

27 Section 1: The recitals set forth above are incorporated herein by reference.

28 Section 2: That the Master Parking Schedule is hereby amended by a) removing the
existing "No Parking At All Times" Zones on the west side of Jasmine Street from 130 feet north
of Columbus Avenue to 150 feet south of Industrial Avenue and on the east side of Jasmine Street

1 from Columbus Avenue to 280 feet north of the railroad tracks and b) establishing “No Parking
2 between the hours of 6:00 p.m. to 6:00 a.m.” Zones on the west side of Jasmine Street from 130
3 feet north of Columbus Avenue to 150 feet south of Industrial Avenue and on the east side of
4 Jasmine Street from Columbus Avenue to 280 feet north of the railroad tracks.

5 Section 3: That the provisions of this resolution shall be operative only when signs are
6 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
7 limitations or prohibitions herein established.

8 Section 4: The provisions of this amendment shall be operative as of the date of adoption
9 of this resolution.
