

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REVISE THE
5 EXISTING PREFERENTIAL PARKING ZONE ON THE NORTH SIDE OF
6 TWELFTH STREET AND TO CHANGE THE STATUS OF THE
7 PREFERENTIAL PARKING ZONE FROM TEMPORARY TO PERMANENT.

8 WHEREAS, the Court of Appeals (“Court”) requested that the boundaries of the existing
9 Preferential Parking Zone (“PPZ”) on the north side of Twelfth Street adjacent to their facility be
10 extended easterly to Mulberry Street and changed from a temporary to permanent zone; and

11 WHEREAS, the extension of the existing PPZ adjacent to the Court property would
12 provide needed, additional on-street parking for the Court employees and a permanent status is
13 supported by the Public Works Department; and

14 WHEREAS, on June 1, 2016, the Transportation Board approved staff’s recommendation
15 to revise the boundaries of the existing Preferential Parking Zone on the north side of Twelfth
16 Street west of Mulberry Street and changing the zone status from temporary to permanent.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18 California, as follows:

19 Section 1: The recitals set forth above are incorporated herein by reference.

20 Section 2: That the Master Parking Schedule is hereby amended by a) revising the
21 boundaries of the existing “No Parking between the Hours of 7:00 a.m. to 7:00 p.m. Monday
22 through Friday except holidays, except for vehicles with permits” Zone on the north side of
23 Twelfth Street from “30 feet west of Mulberry Street to 55 feet westerly thereof” to “Mulberry
24 Street to 85 feet westerly thereof” and b) changing the Preferential Parking Zone status from
25 temporary to permanent.

26 Section 3: That the provisions of this resolution shall be operative only when signs are
27 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
28 limitations or prohibitions herein established.

Section 4: The provisions of this amendment shall be operative as of the date of adoption
of this resolution.
