SUBJECT: RIVERSIDE MUNICIPAL CODE UPDATE – TITLES 1-7 AND 18

ISSUE:

The item before the City Council is an update to Titles 1-7 and 18 of the Riverside Municipal Code for congruence with current law and practices.

RECOMMENDATIONS:

That the City Council:

- Find that this ordinance is not subject to CEQA pursuant to Sections 15060(c)(2), 15060(c)(3), and/or 15061(b)(3) of the State CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, as it will not result in a direct or reasonably foreseeable indirect physical change in the environment nor have a significant impact on the environment; and
- 2. Introduce and subsequently adopt the attached ordinance amending Titles 1-7 and 18 of the Riverside Municipal Code for congruence with current law and practices.

BACKGROUND:

The City Clerk and City Attorney partnered with relevant City Departments to conduct a full review of the Riverside Municipal Code to reflect legal updates, incorporate current practices, and delete obsolete sections. This report represents the first in a series of Title groupings to be presented for City Council consideration. Chapters requiring comprehensive revisions will be presented individually at a future date. The attached ordinance intends to address non-substantive, non-controversial Code changes only. The last full legal review occurred in 1997 performed by outside legal counsel. There are no recommended changes to Title 4 Public Meetings and Public Records. The below chart provides a general description of proposed changes.
