

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, REPEALING RESOLUTION NO. 16190  
4 WHICH ESTABLISHED A MAYOR'S NOMINATING AND SCREENING  
5 COMMITTEE.

6 The City Council of the City of Riverside, California, does resolve as follows:

7 WHEREAS, on July 22, 1986, the City Council of the City of Riverside, adopted Resolution  
8 No. 16190 establishing a Mayor's Nominating and Screening Committee for processing  
9 appointments to City boards and commissions to become operative if a proposed Charter  
10 Amendment giving the Mayor a vote on the nomination and appointment of such members was  
11 adopted by the voters at the November 4, 1986 general election; and

12 WHEREAS, the voters approved the Charter Amendment and the Charter language remains  
13 the same today; and

14 WHEREAS, Resolution No. 16190 sets forth the composition of the Mayor's Nominating  
15 and Screening Committee but is currently outdated; and

16 WHEREAS, it was recommended that Resolution No. 16190 be repealed and that the role of  
17 the Mayor's Nominating and Screening Committee be codified into the City Council Rules of  
18 Procedure and Order of Business.

19 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of  
20 Riverside, California, that Resolution No. 16190 adopted by the City Council is hereby repealed its  
21 entirety.
