A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A SEGMENT OF 1-HOUR PARKING ZONE AND ESTABLISH A 30-MINUTE PARKING ZONE ON UNIVERSITY AVENUE.

WHEREAS, the Riverside Community College District’s (“RCCD’s) Renaissance Block project (“Project”) is located at the southwest corner of University Avenue and Market Street; and

WHEREAS, as part of the first phase of RCCD’s Project, RCCD installed a 30-Minute Parking Zone on the south side of University Avenue west of Fairmount Boulevard to provide short-term on-street parking opportunities adjacent to their facilities and has requested formal establishment of the zone; and

WHEREAS, the establishment of the 30-Minute Parking Zone will offer convenient, short-term parking with the desired turn-over of parking spaces facilitating quick uses and drop-offs; and

WHEREAS, lengthier duration student, employee, and visitor parking will be available within the nearby parking garage; and

WHEREAS, creation of the zone and installation of segments of red curb and a passenger loading zone as part of the Project also requires removal of a segment of the 1-Hour Parking Zone on the south side of University Avenue from Market Street to 190 feet east of Chestnut Street from the Master Parking Schedule to accurately reflect the changes; and

WHEREAS, on June 1, 2016, the Transportation Board approved staff’s recommendation to remove the segment of existing 1-Hour Parking Zone and establish a 30-Minute Parking Zone on designated segments of University Avenue.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by a) removing the segment of the “1-Hour Parking At All Times” Zone on the south side of University Avenue from

1 Market Street to 190 feet east of Chestnut Street and b) establishing a “30-Minute Parking
2 between the hours of 8:00 a.m. to 5:00 p.m. Daily” Zone on the south side of University Avenue
3 from 30’ west of Fairmount Boulevard to 80 feet westerly thereof.

4 Section 3: That the provisions of this resolution shall be operative only when signs are
5 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
6 limitations or prohibitions herein established.

7 Section 4: The provisions of this amendment shall be operative as of the date of adoption
8 of this resolution.
