The following Resolutions of Necessity are the subject of this August 8, 2016 Board of Board of Public Utilities Memorandum recommending:

That the Board of Public Utilities:

- 1. Recommend that the City Council consider adoption of thirty-six (36) Resolutions of Necessity authorizing the initiation of eminent domain proceedings to acquire the necessary real property interests to construct the sub-transmission lines connecting the Riverside Energy Resource Center to Harvey Lynn and Freeman Substations as part of RTRP; and
- 2. Approve the minimum expenditure of \$957,800 for deposit into the State Condemnation Fund as part of the eminent domain process based on City of Riverside approved independent appraisals.
