

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, APPROVING THE APPLICATION FOR
4 GRANT FUNDS FROM THE HABITAT CONSERVATION FUND
PROGRAM FOR SYCAMORE CANYON PARK LAND ACQUISITION
(ASSESSOR'S PARCEL NUMBER 252-230-004).

5 WHEREAS, the people of the State of California have enacted the California Wildlife
6 Protection Act of 1990, which provides funds to the State of California for grants to local agencies to
7 acquire, enhance, restore or develop facilities for public recreation and fish and wildlife habitat
8 protection purposes; and

9 WHEREAS, the State Department of Parks and Recreation has been delegated the
10 responsibility for the administration of the Habitat Conservation Fund ("HCF") Program and setting
11 up necessary procedures governing project application under the HCF Program; and

12 WHEREAS, said procedures established by the State Department of Parks and Recreation
13 require the applicant to certify by resolution the approval of applications(s) before submission of
14 said application(s) to the State; and

15 WHEREAS, the City of Riverside, as the applicant, will enter into a contract with the State
16 of California to complete the project(s);

17 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside,
18 California, hereby:

- 19 1. Approves the filing of an application for the Habitat Conservation Fund Program; and
- 20 2. Certifies that said applicant has or will have available, prior to commencement of any
21 work on the project included in this application, the required match and sufficient funds to complete
22 the project; and
- 23 3. Certifies that the applicant has or will have sufficient funds to operate and maintain the
24 project(s); and
- 25 4. Certifies that the applicant has reviewed, understands, and agrees to the provisions
26 contained in the contract shown in the grant administration guide; and
- 27 5. Delegates the authority to the City Manager or his designee to conduct all negotiations,
28 execute and submit all documents, including, but not limited to applications, agreements,

1 amendments, payment requests and so on, which may be necessary for the completion of the project;
2 and

3 6. Agrees to comply with all applicable federal, state and local laws, ordinances, rules,
4 regulations and guidelines.
