

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.  
4 21052 TO AMEND THE FRINGE BENEFITS AND SALARY  
5 PLAN, TO REFLECT VARIOUS UPDATES AND CHANGES TO  
6 JOB CLASSIFICATIONS/TITLES.

19 Memorandum and in Exhibits "A" and "B" attached hereto and incorporated herein by reference.

20 Section 2: The provisions of this amendment shall be effective upon adoption and  
21 operative as set forth in Exhibits "A" and "B" as amended and attached hereto.

22 Section 3: Authorize the City Manager, or his designee, to make minor, non-  
23 substantive changes to Master Fringe Benefits and Salary Plan and any related policies,  
24 procedures or documents necessary to implement these provisions.
