SUBJECT: PROFESSIONAL CONSULTANT SERVICES PANEL FOR CAPITAL

IMPROVEMENT PROJECTS AT THE REGIONAL WATER QUALITY CONTROL PLANT AND TEQUESQUITE LANDFILL FROM RFQ 1592 - AWARD OF THIRTY THREE MASTER PROFESSIONAL CONSULTANT SERVICES AGREEMENTS TO VARIOUS FIRMS FOR SERVICES THROUGH

DECEMBER 31, 2019, WITH A MAXIMUM AMOUNT OF \$750,000 EACH

ISSUE:

Approve a Professional Consultant Services Panel to include thirty-three (33) Master Professional Consultant Services Agreements for capital improvement project engineering services through December 31, 2019, for projects at the RWQCP and Tequesquite Landfill, with a maximum amount of \$750,000 each.

RECOMMENDATIONS:

That the City Council:

- 1. Approve the Master Professional Consultant Services Panel Agreements with thirty-three (33) professional firms through December 31, 2019, as listed in this report;
- 2. Authorize the City Manager, or his designee, to execute the Master Professional Service Agreements with the firms listed in this report; and
- 3. Authorize the City Manager, or his designee, to execute project Supplemental Agreements as needed under the Master Agreements, for a total not to exceed amount of \$750,000 per firm over the agreement term.

BACKGROUND:

On January 13, 2004, City Council authorized the establishment of a professional consultant services panel to support the Wastewater Division's RWQCP capital improvement program. The current consultant panel expired in December 31, 2015.

The Wastewater Division's recently adopted 2016-2018 Two-Year Budget and Five-Year Capital Improvement Program includes approximately \$9.2 million of work to accomplish over the next three fiscal years.

DISCUSSION:

The Master Consultant Services Panel will provide engineering services for the numerous smaller capital projects at the RWQCP and Tequesquite Landfill. The utilization of the panel ensures that projects are completed in an expeditious manner to maintain satisfactory operation and regulatory requirements.

For individual projects, the Public Works Department will solicit proposals from all consultant firms on the panel within their respective categories of expertise. A review panel will select the best proposal based on project approach, strength of the proposed project team, cost, and schedule. Funds for each assigned project are approved as part of the City Council budget and Capital Improvement Project budget adoption. The department will negotiate a supplemental agreement with the selected firm for each project, including scope and fee, with the City Manager, or his designee, having the authority to execute the supplemental agreement.

For larger and more complex projects, typically with an engineer's estimated project value of approximately \$500,000 or more, the formal project specific request for bids will be utilized for the services needed.

RFQ 1592

On March 10, 2016, the Public Works Department issued a Request for Qualifications (RFQ No. 1592) through the Finance Department's website. The range of engineering services being sought include, but are not limited to: wastewater planning and engineering design, geotechnical, soil and material testing, specialty construction inspection, control system programming, regulatory and environmental compliance services, air quality testing and compliance, landfill monitoring and remediation, structural, mechanical and sewer collection system design, instrumentation control, odor control, air quality testing and compliance.

A panel consisting of Public Works Department staff reviewed the proposals and found all thirty-three (33) firms are qualified in their respective areas. Of the proposals received, twenty-three (23) are from firms who were on the previous consultant services panel and ten (10) are from new firms.

Master Panel Agreements

Attached is the Master Professional Service Agreement. The terms of the agreements are for services through December 31, 2019. A cap of \$750,000 has been established for each firm. Each consultant has been pre-qualified based on the RFQ results into one or more of the following categories based on their area of expertise.

- 1. Wastewater Planning and Engineering (WPE)
- 2. Geotechnical and Material Testing (GMT)
- 3. Specialty Inspection (SI)
- 4. Control System Programming (CSP)
- 5. Landfill Studies, Monitoring and Remediation (LSMR)
- 6. Air Quality Testing and Compliance (AQC)
- 7. Regulatory and Environmental Compliance (REC)
