## LHMP BACKGROUND

### **1. Hazard Mitigation Planning is required under the Disaster Mitigation Act of 2000 (DMA 2000)**

- A. Local Hazard Mitigation Plan (LHMP) helps achieve eligibility for Federal Emergency Management Agency (FEMA) pre-disaster and post-disaster mitigation grant assistance
- B. Must be updated every 5 years
- C. City LHMP last approved in 2012

### 2. What is a LHMP

- A. Identify hazards
- B. Review past disaster occurrences
- C. Estimate probability of future occurrences
- D. Set mitigation goals to reduce or eliminate long-term risk to people and property from natural and other hazards

## REGIONAL PLANNING

### 1. **Joined the Riverside County Multi-Jurisdictional Hazard Mitigation (MJHMP) Plan in June 2016**

- A. 2017 LHMP Update initially a single jurisdiction plan for the City of Riverside
- B. The MJHMP is a LHMP with multiple jurisdictions coming together to develop a main plan

## REGIONAL PLANNING

### A. Combining with Riverside County

- i. City LHMP will become an annex to the MJHMP
  - i. Annex is specific to the city and references the main plan
- ii. Scheduling and data technical assistance more advantageous
- iii. Regional planning will allow for more comprehensive plan

## DATA GATHERING

### 1. Information gathering process in numbers

- A. Survey (175 responses)
- B. Public Meetings (15 with 5 to 45 people at each)
  - i. Neighborhood Groups, Council, Riverside County OAPC
- C. Community Partner Meetings (4)
  - i. Hospitals, Educational Institutions, CERT Team
- D. LHMP Planning Team Meetings (9)
  - i. City Planning Team made up of representatives from City Departments

2. OEM will bring final draft back to Public Safety Committee in Spring 2017
3. Riverside County will submit MJHMP and City of Riverside MJHMP Annex in Summer 2017 to CalOES/FEMA for approval
