

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A SEGMENT
OF NO PARKING ON INDIANA AVENUE.

5 WHEREAS, the recently completed Indiana Avenue Repaving Project included restriping
6 within the segment of Myers Street to Harrison Street to provide a two-way left-turn lane and
7 allow for on-street parking adjacent to the residential and commercial properties on Indiana
8 Avenue within this segment of roadway. As a result, No Parking signage on Indiana Avenue
9 from Myers Street to Harrison Street was removed upon project completion; and

10 WHEREAS, the existing No Parking Any Time Zone will remain in effect on Indiana
11 Avenue from Van Buren Boulevard to Myers Street. Removal of the proposed segment of the No
12 Parking Any Time Zone is necessary to update the Master Parking Schedule and accurately
13 reflect the remaining portions of the zone; and

14 WHEREAS, on August 3, 2016, the Transportation Board ("Board") unanimously
15 recommended the proposal to remove the segment of the existing No Parking Any Time Zone on
16 both sides of Indiana Avenue from Myers Street to Harrison Street.

17 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18 California, as follows:

19 Section 1: The recitals set forth above are incorporated herein by reference.

20 Section 2: That the Master Parking Schedule is hereby amended by removing the segment
21 of the existing "No Parking Any Time" Zone on both sides of Indiana Avenue from Myers Street
22 to Harrison Street.

23 Section 3: That the provisions of this resolution shall be operative only when signs are
24 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
25 limitations or prohibitions herein established.

26 Section 4: The provisions of this amendment shall be operative as of the date of adoption
27 of this resolution.
