A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A PREFERENTIAL PARKING ZONE ON SAN RAFAEL WAY.

WHEREAS, the Public Works Department received a petition from 100% of residents on San Rafael Way between Magnolia Avenue and Potomac Street requesting establishment of a Preferential Parking Zone ("PPZ") within the residential section of the entire east side of the street and on the portion of the west side of the street south of the existing commercial property located at 3796 San Rafael Way. The residents indicate that overflow parking from nearby apartment complexes located on the north side of Magnolia Avenue is limiting on-street parking opportunities for residents and their guests; and

WHEREAS, the establishment of the PPZ would restrict outside parking sources and provide residents and their guests with reasonable access to on-street parking evenings and 13 overnight while maintaining unrestricted parking during typical business hours; and 14

WHEREAS, on August 3, 2016, the Transportation Board ("Board") unanimously 15 recommended the proposal to establish a Preferential Parking Zone on designated segments of 16 San Rafael Way north of Potomac Street. 17

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 18 California, as follows: 19

Section 1: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by establishing a "No 21 Parking Zone Between the Hours of 6:00 p.m. to 8:00 a.m. Daily, with Preferential Permit 22 Parking for residents" Zone on the east side of San Rafael Way between Magnolia Avenue to 23 2.4 Potomac Street and on the west side of San Rafael Way from 185 feet south of Magnolia Avenue 25 to Potomac Street.

Section 3: That the provisions of this resolution shall be operative only when signs are 26 erected on that portion of the street set forth in Section 2 above, giving notice of the parking 27 limitations or prohibitions herein established. 28
