2	A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A
4	PREFERENTIAL PARKING ZONE ON BIRCH STREET.
5	WHEREAS, the Public Works Department received a petition from 82% of residents on
6	Birch Street requesting establishment of a 30-Minute Parking between the hours of 8:00 a.m. to
7	8:00 p.m. Monday through Saturday, with Preferential Permit Parking for residents" Zone
8	("PPZ"). The residents indicate that overflow employee and patron parking from nearby
9	businesses located on Jurupa Avenue is limiting on-street parking opportunities for residents and
10	their guests; and
11	WHEREAS, the establishment of the PPZ would restrict outside parking sources and
12	provide residents and their guests with reasonable access to on-street parking; and
13	WHEREAS, on August 3, 2016, the Transportation Board ("Board") unanimously
14	recommended a modified proposal to establish a 2-Hour Preferential Permit Parking Zone on both
15	sides of Birch Street from Jurupa Avenue to Maplewood Place to better balance the needs of
16	residents and business patrons of the nearby businesses.
17	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
18	California, as follows:
19	Section 1: The recitals set forth above are incorporated herein by reference.
20	Section 2: That the Master Parking Schedule is hereby amended by establishing a "2-
21	Hour Parking between the Hours of 8:00 a.m. to 8:00 p.m. Monday through Saturday, with
22	Preferential Permit Parking for residents" Zone" on both sides of Birch Street from Jurupa
23	Avenue to Maplewood Place.
24	Section 3: That the provisions of this resolution shall be operative only when signs are
25	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
26	limitations or prohibitions herein established.

1	Section 4: The provisions of this amendment shall be operative as of the date of adoption
2	of this resolution.
