7	intention to levy an annual assessment, and to hold a public hearing to consider protests to the
8	annual levying of assessments for the Arlington Business Improvement District; and
9	WHEREAS, the City Council has held a public hearing and heard, considered, and ruled
10	on all written and oral protests to the imposition of the annual levy at said public hearing.
11	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
12	California, pursuant to Section 36535 of the Streets & Highways Code, as follows:
13	1. The 2015-2016 annual report of the Arlington Business Partnership, acting in its
14	capacity as the advisory board to the Arlington Business Improvement District, is confirmed.
15	2. The levy for the Arlington Business Improvement District is imposed for the fiscal
16	year 2016-2017 beginning November 1, 2016, at the rate of 90% of the business tax charge, not
17	to exceed \$400.00 per business.
