1 2 RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA. AUTHORIZING THE CITY MANAGER TO FILE 3 FINANCIAL ASSISTANCE APPLICATION FOR FINANCING AGREEMENT WITH THE STATE WATER RESOURCES CONTROL BOARD FOR THE 4 JACKSON STREET RECYCLED WATER PIPELINE - PHASES I AND II PROJECT. 5 6 WHEREAS, the City of Riverside, through its Public Utilities Department (the "City") 7 desires to finance the costs of construction and/or reconstruction of certain public facilities and 8 improvements related to its recycled water system (Jackson Street Recycled Water Pipeline -9 Phases I and II), including certain treatment facilities, pipelines and other infrastructure (the 10 "Project"); and WHEREAS, the City intends to finance the construction and/or reconstruction of the 11 12 Project or portions of the Project with monies ("Project Funds") provided by the State of 13 California, acting by and through the State Water Resources Control Board ("State Water Board"); 14 and 15 WHEREAS, the State Water Board may fund the Project Funds with proceeds from the 16 sale of obligations and interest upon which is excluded from gross income for federal income tax 17 purposes (the "Obligations"). NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Riverside, 18 19 California as follows: 20 SECTION 1. The City Manager (the "Authorized Representative") or his/her designee, is 21 hereby authorized and directed to sign and file, for and on behalf of the City of Riverside, a 22 Financial Assistance Application for a financing agreement from the State Water Resources 23 Control Board for the planning, design and construction of the Jackson Street Recycled Water 24 Pipeline - Phases I and II (the "Project"). 25 SECTION 2. The Authorized Representative, or his/her designee, is designated to 26 provide the assurances, certifications, and commitments required for the financial assistance 27 application, including executing a financial assistance agreement from the State Water Resources 28 Control Board and any amendment or changes thereto.

4	SECTION 4. The City hereby agrees and further does authorize the aforementioned
5	Authorized Representative, or his/her designee, to certify that the City has and will comply with
6	all applicable state and federal statutory and regulatory requirements related to any financing or
7	financial assistance received from the State Water Resources Control Board.
8	SECTION 5. The Authorized Representative, or his/her designee, is hereby authorized to
9	negotiate and execute a finance assistance agreement from the State Water Resources Control
10	Board and any amendments or change orders thereto and certify financing agreement
11	disbursements on behalf of the City.
