

## **MINUTES**

### **TRANSPORTATION BOARD City of Riverside Wednesday, August 3, 2016, 5:30 p.m. Art Pick Council Chamber**

Chair Angel called the meeting to order at 5:32 p.m.

#### **APPROVAL OF MINUTES**

Motion was made by Member Nelson and seconded by Chair Angel approving the June 1, 2016, Transportation Board meeting minutes as presented. Motion carried unanimously with Vice-Chair Kirby and Member Timmons abstaining.

R.A. "Barney" Barnett spoke in regards to a proposed Metrolink station in Highgrove.

#### **DISCUSSION CALENDAR**

##### **BANDINI AVENUE – REVISION OF PREFERENTIAL PARKING ZONE**

Following discussion motion was made by Vice-Chair Kirby and seconded by Member Nelson recommending that the City Council approve the revision of the existing "No Parking Any Time, with Preferential Permit Parking for residents" Zone on the south side of Bandini Avenue to change the westerly zone boundary from "Olivewood Avenue to 145 feet westerly of Osburn Place" to "Olivewood Avenue to 205 feet west of Osburn Place". Motion carried unanimously.

##### **BIRCH STREET – ESTABLISHMENT OF PREFERENTIAL PARKING ZONE**

Four residents in support, a resident and two business owners opposed and one resident who was neutral spoke regarding the request to establish a 30-Minute Preferential Parking Zone on Birch Street. Following discussion motion was made by Member Nelson and seconded by Vice-Chair Kirby recommending that the City Council approve establishment of a "2-Hour Parking between the hours of 8:00 a.m. to 8:00 p.m. Monday through Saturday, with Preferential Permit Parking for residents" Zone on both sides of Birch Street from Jurupa Avenue to Maplewood Place. Motion carried unanimously.

##### **INDIANA AVENUE – REMOVAL OF SEGMENT OF NO PARKING ANY TIME ZONE**

Following discussion motion was made by Chair Angel and seconded by Member Nelson recommending that the City Council approve removal of the segment of the existing "No Parking Any Time" Zone on Indiana Avenue from Myers Street to Harrison Street. Motion carried unanimously.

### **SAN RAFAEL WAY – ESTABLISHMENT OF PREFERENTIAL PARKING ZONE**

One resident spoke in support of the establishment of a Preferential Parking Zone (PPZ) on designated segments of San Rafael Way. Following discussion motion was made by Member Nelson and seconded by Member Kirby recommending that the City Council approve establishment of a “No Parking between the hours of 6:00 p.m. to 8:00 a.m. Daily, with Preferential Permit Parking for residents” Zone on the east side of San Rafael Way from Magnolia Avenue to Potomac Street and on the west side of San Rafael Way from 185’ south of Magnolia Avenue to Potomac Street. Motion carried unanimously.

Following discussion and without formal motion the Transportation Board unanimously received and ordered filed the update.
