SUBJECT: AWARD BID NO. 7430, FOR DELIVERY AND PNEUMATIC INSTALLATION OF CERTIFIED AND ENGINEERED WOOD PLAYGROUND CHIPS FOR PLAYGROUNDS IN VARIOUS CITY PARKS TO TURBOSCAPE, INC., OF LAKE ELSINORE, CALIFORNIA - IN THE AMOUNT OF \$110,400

ISSUE:

Award Bid No. 7430 and approve a construction contract for installation of certified and engineered wood playground chips to Turboscape, Inc., of Lake Elsinore, California.

RECOMMENDATIONS:

That the City Council:

1. Award Bid No. 7430 – Delivery and Pneumatic Installation of Certified and Engineered Wood Playground Chips for Playgrounds in Various City Parks to Turboscape, Inc., of Lake Elsinore, California, in the amount of \$110,400; and
2. Authorize the City Manager, or his designee, to execute a construction contract with Turboscape, Inc., of Lake Elsinore, California, for Bid No. 7430, including making minor and non-substantive changes.

BACKGROUND:

In order to continue providing safe play areas, the wood playground chips at Bergamont, Castlevue, Collett, Doty Trust, Fairmount, Hunter Hobby, Patterson, Rancho Loma, Rutland, Ryan Bonaminio, Taft, and Thundersky Parks are in need of replenishment. The following table shows the bid items, locations, and bid amounts:

On July 14, 2016, the Purchasing Division posted bid documents on the City's website for Bid No. 7418 – Certified and Engineered Playground Wood Chips for Various City Parks, and received no responsive bids by August 8, 2016.

On August 18, 2016, the Purchasing Division posted bid documents on the City's website for Bid No. 7430, and received one responsive bid on September 1, 2016. The lowest bidder is Turboscape, Inc., of Lake Elsinore, California. The Purchasing Services Supervisor's Bid Award Recommendation Report indicates the bid meets the criteria to be considered responsive and responsible. The State Contractor's Licensing Board records indicate this bidder's license is current, active, and in good standing.

The Purchasing Services Supervisor concurs with the recommendation above.

FISCAL IMPACT:

The total fiscal impact of the action is \$110,400. The funds are available in the Park Refurbishing Program account number 9721651203 - 44030100.
