5	The City Council of the City of Riverside does ordain as follows:

12	other method, any merchandise or printed matter within any building owned by the City or
13	the Pedestrian Mall. Nothing in this Section shall prohibit solicitation or direct sales by any
14	person permitted to engage in such activities pursuant to a lease or rental agreement or a
15	permit issued by the City.

7	Section 4: The City Clerk shall certify to the adoption of this ordinance and cause
8	publication once in a newspaper of general circulation in accordance with Section 414 of the Charter
9	of the City of Riverside. This ordinance shall become effective on the 30th day after the date of its
