SUBJECT: ANNUAL UPDATE FOR FOX PERFORMING ARTS CENTER AND RIVERSIDE

MUNICIPAL AUDITORIUM

ISSUE:

Receive an annual update from Live Nation Worldwide, Inc., operator of the Fox Performing Arts Center and Riverside Municipal Auditorium.

RECOMMENDATIONS:

That the City Council receive the annual update from Live Nation Worldwide, Inc., operator of the Fox Performing Arts Center and Riverside Municipal Auditorium.

BACKGROUND:

On October 8, 2013, the City Council approved the Agreement for the operation and management of the Fox Performing Arts Center ("Fox") and Riverside Municipal Auditorium ("RMA") with Live Nation. Live Nation is to provide for the management and operation of the Premises as a first-class live entertainment and special event venue consistent with the goals of the City. The RMA is owned by the City and therefore all uses are designed to create a positive economic impact, stimulate growth for the region and provide for the cultural and intellectual enrichment of the community. Live Nation recognizes these goals and is working diligently to schedule, promote and provide diverse entertainment and special events.
