A RESOLUTION OF THE OVERSIGHT BOARD FOR CITY OF RIVERSIDE AS SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF RIVERSIDE APPROVING A PURCHASE AND SALE AGREEMENT WITH PELICAN COMMUNITIES, LLC FOR THE PURCHASE OF THE PROPERTY LOCATED AT 3575-3661 MERRILL AVENUE IDENTIFIED AS ASSESSOR'S PARCEL NUMBERS 225-140-001, -002, -003, -004, -005, AND -006 TO FACILITATE THE CONSTRUCTION OF A MIXED USE MULTI-FAMILY HOUSING AND COMMERCIAL DEVELOPMENT PROJECT.

WHEREAS, on January 10, 2012, the City Council adopted Resolution No. 22322 re-affirming the authorization of the City of Riverside to become Successor Agency to the Redevelopment Agency of the City of Riverside ("Successor Agency") pursuant to ABx1 26; and

WHEREAS, subsequent legislation entitled "Assembly Bill 1484", signed into law on June 27, 2012, makes substantive amendments to ABx1 26 and specifically includes a requirement, set forth at Health & Safety Code section 34179(e), that all actions taken by the oversight board be adopted by resolution; and

WHEREAS, pursuant to the Long-Range Property Management Plan, which was approved by the Department of Finance on March 6, 2014, the Successor Agency set forth its intention to sell approximately 3.17 acres of vacant land located at 3575-3661 Merrill Avenue, identified as Assessor's Parcel Numbers 225-140-001, -002, -003, -004, -005, and -006 ("Property"), in accordance with Health and Safety Code Section 34191.5(c)(2) and to facilitate the construction of a mixed use multifamily housing and commercial development project; and

WHEREAS, the Successor Agency desires to sell the Property to Pelican Communities, LLC ("Developer") pursuant to that certain Purchase and Sale Agreement ("Agreement") attached hereto as Exhibit "A"; and

WHEREAS, Developer desires to purchase the Property from the Successor Agency at fair market value pursuant to the Agreement; and

WHEREAS, Developer agrees to purchase the Property subject to the existing conditions outlined in the Oversight Board Memorandum.

NOW, THEREFORE, BE IT RESOLVED by the Oversight Board for the City of Riverside as the Successor Agency to the Redevelopment Agency of the City of Riverside, as follows:

1	Section 1: Pursuant to Health & Safety Code section 34181 (e), the Oversight Board for the
2	City of Riverside as the Successor Agency to the Redevelopment Agency of the City of Riverside does
3	hereby approve the Agreement between the Successor Agency and Pelican Communities, LLC, and
4	direct the Successor Agency to transmit this resolution to the Department of Finance.
5	Section 2: Authorize the City Manager, or his designee, on behalf of the Successor Agency to
6	execute the Purchase and Sale Agreement and all related documents to complete the sale.
