## RESOLUTION NO.

A RESOLUTION OF THE OVERSIGHT BOARD FOR CITY OF RIVERSIDE AS SUCCESSOR AGENCY TO THE REDEVELOPMENT AGENCY OF THE CITY OF RIVERSIDE APPROVING AN 18-MONTH RIGHT OF ENTRY AGREEMENT WITH TILDEN-COIL CONSTRUCTORS, LLC FOR THE USE OF SUCCESSOR AGENCY-OWNED VACANT LAND LOCATED AT 8717 INDIANA AVENUE BEARING ASSESSOR PARCEL NUMBER 233-140-017.

WHEREAS, on January 10, 2012, the City Council adopted Resolution No. 22322 re-affirming the authorization of the City of Riverside to become Successor Agency to the Redevelopment Agency of the City of Riverside ("Successor Agency") pursuant to ABx1 26; and

WHEREAS, subsequent legislation entitled "Assembly Bill 1484", signed into law on June 27, 2012, makes substantive amendments to ABx1 26 and specifically includes a requirement, set forth at Health & Safety Code section 34179(e), that all actions taken by the oversight board be adopted by resolution; and

WHEREAS, pursuant to Right of Entry Guidelines, which were approved by the Oversight Board on August 30, 2012 and later amended by Oversight Board approval on October 11, 2012, the Successor Agency desires to enter into an 18-month Right of Entry agreement with Tilden-Coil Constructors, LLC ("Tilden-Coil") for vacant Successor Agency-owned land located at 8717 Indiana Avenue, bearing Assessor Parcel Number 233-140-017 ("Property"); and

WHEREAS, the Successor Agency desires to let Tilden-Coil utilize the Property pursuant to that certain Right of Entry Agreement ("Agreement") attached hereto as Exhibit "A"; and

WHEREAS, Tilden-Coil desires to utilize the Property pursuant to the Agreement; and WHEREAS, Tilden-Coil agrees to utilize the Property subject to the existing conditions outlined in the Oversight Board Memorandum.

NOW, THEREFORE, BE IT RESOLVED by the Oversight Board for the City of Riverside as the Successor Agency to the Redevelopment Agency of the City of Riverside, as follows:

Section 1: Pursuant to Health & Safety Code section 34181 (e), the Oversight Board for the City of Riverside as the Successor Agency to the Redevelopment Agency of the City of Riverside does hereby approve the Agreement between the Successor Agency and Tilden-Coil Constructors, LLC, and direct the Successor Agency to transmit this resolution to the Department of Finance.

1	Section 2: Authorize the City Manager, or his designee, on behalf of the Successor Agency to
2	execute the Right of Entry Agreement and all related documents to complete the transaction.
