## **RESOLUTION NO.**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION HELD IN SAID CITY ON THE 8th DAY OF NOVEMBER, 2016, DECLARING THE RESULTS THEREOF AND SETTING FORTH SUCH OTHER MATTERS AS ARE PROVIDED BY LAW.

6 WHEREAS, a Special Municipal Election was held and conducted in the City of
7 Riverside on the 8th day of November, 2016, as required by law for the purpose of voting on
8 Measure Z City of Riverside Public Safety and Vital City Services Measure; and

WHEREAS, notice of said election was duly and regularly given in the time, form and manner as provided by law; voting precincts were properly established; election officers were appointed and in all respects said election was held and the returns made and declared in the time, form, and manner as required by the provisions of the Charter of the City of Riverside and the Elections Code of the State of California for the holding of elections in the City of Riverside; and

WHEREAS, pursuant to Resolution No. 23042 adopted on the 9th day of August, 2016, the appropriate County official canvassed the returns of said election and has certified the results to this City Council and said results are received, attached, and made a part hereof as Exhibit "A".

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
 follows:

<u>Section 1:</u> That there were eighty-five (85) voting precincts citywide.

Section 2: That said Special Municipal election was held for the purpose of submitting
 to the qualified electors of the City of Riverside the question as to whether Measure Z, and more
 particularly described in Section 1 of Resolution No. 23042, should be approved.

25 Section 3: The measure was submitted to the qualified electors and designated as
 26 Measure Z on the ballot entitled, "City of Riverside Public Safety and Vital City Services
 27 Measure."

3	MEASURE Z - Measure approved
4	CITY OF RIVERSIDE PUBLIC SAFETY AND VITAL CITY SERVICES MEASURE:
5	To prevent cutting police, firefighters, paramedics, 911 emergency response,
6	antigang/drug programs, homelessness reduction and youth after-
7	school/senior/disabled services; to repair local streets/potholes/ infrastructure; and
8	to provide other general services, shall a one-cent transaction and use tax (sales
9	tax) be implemented providing \$48,000,000 annually through 2036 unless extended
10	by the voters, requiring independent audits with no funds to Sacramento, all funds
11	remaining for Riverside?
12	That the number of votes given in each precinct and the number of votes given in the City
13	for and against the Measure is listed on the attached Exhibit "A".
14	Section 6: The City Council does declare and determine that a majority of the qualified
15	electors voting on Measure Z voted in favor thereof, and pursuant to the Constitution of the State
16	of California and the laws of the State of California, Measure Z is declared to have carried.
17	Section 7: That the City Clerk shall enter on the records of the City Council of said City
18	a statement of the results of the Special Municipal election held on November 8, 2016, showing:
19	(1) The whole number of votes cast in the City;
20	(2) The Measure voted on; and
21	(3) The number of votes given in the City for and against the Measure.
