

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, RECITING THE FACT OF THE
4 SPECIAL MUNICIPAL ELECTION HELD IN SAID CITY ON THE
5 8th DAY OF NOVEMBER, 2016, DECLARING THE RESULTS
6 THEREOF AND SETTING FORTH SUCH OTHER MATTERS AS
7 ARE PROVIDED BY LAW.

8 WHEREAS, a Special Municipal Election was held and conducted in the City of
9 Riverside on the 8th day of November, 2016, as required by law for the purpose of voting on
10 Measure Z City of Riverside Public Safety and Vital City Services Measure; and

11 WHEREAS, notice of said election was duly and regularly given in the time, form and
12 manner as provided by law; voting precincts were properly established; election officers were
13 appointed and in all respects said election was held and the returns made and declared in the
14 time, form, and manner as required by the provisions of the Charter of the City of Riverside and
15 the Elections Code of the State of California for the holding of elections in the City of Riverside;
16 and

17 WHEREAS, pursuant to Resolution No. 23042 adopted on the 9th day of August, 2016,
18 the appropriate County official canvassed the returns of said election and has certified the results
19 to this City Council and said results are received, attached, and made a part hereof as Exhibit
20 "A".

21 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
22 follows:

23 Section 1: That there were eighty-five (85) voting precincts citywide.

24 Section 2: That said Special Municipal election was held for the purpose of submitting
25 to the qualified electors of the City of Riverside the question as to whether Measure Z, and more
26 particularly described in Section 1 of Resolution No. 23042, should be approved.

27 Section 3: The measure was submitted to the qualified electors and designated as
28 Measure Z on the ballot entitled, "*City of Riverside Public Safety and Vital City Services*
Measure."

Section 4: That the whole number of votes cast Citywide was _____.
