RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING FOR WATER UTILITY PURPOSES ONLY A PORTION OF LOT "B" OFFERED FOR DEDICATION BY THE TRACT MAP FOR COUNTRY CLUB PARK

WHEREAS, in connection with the tract map for Country Club Park as shown by map on file in Book 11 of Maps, at Page 64 thereof, Records of Riverside County, California, Lot "B" thereof was offered for dedication for public use for street purposes; and

WHEREAS, the City Council of the City of Riverside previously accepted all portions of said Lot "B" by Resolution Nos. 4933, 5102 and 17273 in part for public street purposes to be known as a portion of Victoria Hill Drive and the remainder for electrical utility purposes only; and

WHEREAS the City of Riverside now wishes to accept the remainder portion of said Lot "B" for water utility purposes only.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That the real property as described and as depicted on Exhibit A, attached hereto and incorporated herein by this reference, offered for dedication for public street purposes by the Tract Map for Country Club Park on file in Book 11 of Maps, at Page 64 thereof, Records of Riverside County, California, is hereby accepted by the City of Riverside for water utility purposes only, including the right to construct and maintain waterlines and related infrastructure.

Section 3: The City Clerk of the City of Riverside, California, is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.
