**LOCATION:** 5573 Arlington Avenue


**PROPOSAL:** The Planning Commission recommends construction of a 2, 200-square-foot drive-thru restaurant with the following entitlements to be considered: (1) rezone .55 acre from O - Office Zone to CR - Commercial Retail Zone; (2) conditional use permit to allow drive-thru facility; and (3) design review of plot plan, building elevations, and landscape plan, situated on the north side of Arlington Avenue approximately 140 feet east of Phoenix Avenue.

**ENVIRONMENTAL DETERMINATION:** The Planning Commission recommends finding that the proposed project constitutes an infill development project and is therefore categorically exempt from provisions of the California Environmental Quality Act (CEQA) per Section 15332 of the CEQA Guidelines as this project will not have a significant effect on the environment.
