CITY OF RIVERSIDE NOTICE OF PUBLIC COMMENT PERIOD FOR AMENDMENT TO THE 2016-2017 ANNUAL ACTION PLAN

Notice is hereby given for a public comment period to consider an amendment to the 2016-2017 Annual Action Plan. All persons interested in providing input or comment may do so at the addresses listed below.

The U.S. Department of Housing and Urban Development (HUD) approved the City of Riverside's Five-Year Consolidated Plan in 2015. The Consolidated Plan provides an inventory of existing programs and activities, resources, demographics, unmet needs, and identifies strategies and resources [such as Community Development Block Grant funds (CDBG), HOME, Housing Opportunities for People with AIDS (HOPWA), and Emergency Solutions Grant (ESG)] needed to implement programs and activities to address the unmet needs. With the approval of the Consolidated Plan, it is the Annual Action Plan that incrementally addresses and implements identified programs and activities prepared and submitted to HUD for approval. The Annual Action Plan prepared for 2016-2017 implements the strategies and goals identified in the Consolidated Plan.

Federal Regulation 24 CFR 91.105 requires the City to notify and provide its citizens an opportunity to comment and provide input on proposed changes to an approved plan. This notice serves this purpose and allows the City to comply with the law. The proposed amendment to the approved Plan affected by this Notice is the City's proposal to reprogram CDBG funds in the amount of \$100,000 from the 2016-2017 ADA Street Improvements which entailed the construction of 26 new pedestrian ramps at various locations throughout Ward 1 to the construction of sidewalks and pedestrian ramps along the Fairmount Park area, Locust Street, and Redwood Drive to provide improved pedestrian access to the park from nearby neighborhoods. The Riverside City Council will consider the amendment at their meeting scheduled for Tuesday, January 24, 2017, beginning at 6:30 p.m. in the Art Pick Council Chambers, 3900 Main Street Riverside, CA, 92522.

Both oral and written comments may be submitted for this item no later than Monday, January 23, 2017 by 5 p.m. Anyone who is interested, may provide input and comments to the City of Riverside Community & Economic Development Department, Third Floor, 3900 Main Street, Riverside, CA 92522.
