## RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 21322 TO REVISE THE PARKING RATE AND HOUR SCHEDULE TO REFLECT THE TWO-YEAR IMPLEMENTATION PLAN WHICH INCLUDES RATE CHANGES AND PROGRAM IMPROVEMENTS AND REPEALING RESOLUTION NO. 22939.

WHEREAS, on January 16, 2007, by adoption of Resolution 21322, the City Council amended the Downtown Parking Rate and Hour Schedule for the various Municipal Parking Facilities within the Downtown area; and

WHEREAS, on November 27, 2012, by adoption of Resolution No. 22478, the City Council amended Resolution No. 21322 and the Downtown Parking Rate and Hour Schedule to add hours of operation and establish rates for the Fox Entertainment Plaza Garage ("Garage 7"); and

WHEREAS, on November 19, 2013, by adoption of Resolution No. 22600, the City Council amended Resolution No. 21322 and the Downtown Parking Rate and Hour Schedule to designate lot 16 as a permit parking lot; and

WHEREAS, on December 17, 2013, by adoption of Resolution No. 22615, the City Council amended Resolution No. 21322 and renamed the Downtown Parking Rate and Hour Schedule to the Parking Rate and Hour Schedule ("Schedule") and amended the Schedule to establish permit fees for Parklets; and

WHEREAS, the City desires to amend Resolution No. 21322 and the Parking Rate and Hour Schedule to add a two-year implementation plan to modify rates and make enhancements to the parking program, pursuant to the provisions noted on the Parking Rate and Hour Schedule as set forth in Exhibit "A" attached hereto and incorporated herein; and

WHEREAS, on December 15, 2015, the City Council adopted Resolution No. 22939 amending Resolution No. 20169 and designating Garage 6 and Lot 27 as permit parking lots; and

WHEREAS, it has been discovered that Resolution No. 22939 included inaccurate background information; and

WHEREAS, the City desires to repeal Resolution No. 22939 and include the action taken therein into this resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, 1 2 California as follows: 3 Section 1: Resolution No. 21322 is hereby amended to add a two-year implementation plan to modify rates and make enhancements to the parking program. 4 5 Section 2: That the Parking Rate and Hour Schedule is hereby revised as set forth in Exhibit "A" attached hereto and incorporated herein by reference, which revisions shall become 6 effective upon the adoption of this resolution. 7 8 Section 3: Resolution No. 22939 is hereby repealed in its entirety. 9 ADOPTED by the City Council this day of , 2017. 10 11 WILLIAM R.
